Dear Section 40

Thank you very much for your e-mail about the UFO that you and your friend saw in Barnet.

At the Ministry of Defence we receive a lot of UFO reports but I want to reassure you that we have never received one that we thought was a threat to people's safety.

We only ever investigate a handful of reports like yours a year because it would be very expensive to investigate them all, but we suspect that if we did, most of them would be caused by aircraft, stars or the light playing tricks with people's eyes. When we do investigate them, it's only to see if the country's airspace might have been affected but we haven't any evidence of this so far.

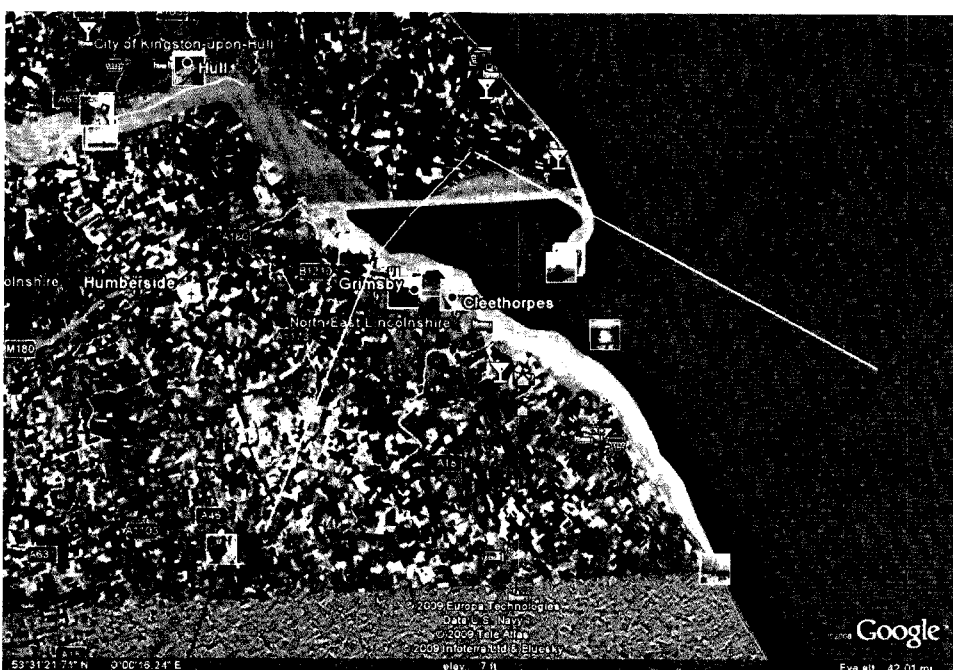

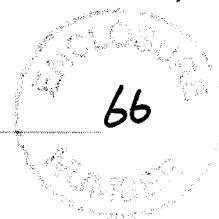

"Anyway, with reference to what I saw on my trip to Gatwick on Monday 1st September 2008, here is my account of what took place.

I was en route to collect my neighbour's wife and children from her return trip from Toronto. Her time of arrival was 11am, I was advised by my neighbour that I should plan to be there about 11.30am, although I wanted to be a little earlier on arrival for parking and a coffee, but found myself running late after getting to grips with a new Satellite Navigation system and moments of slow motorway traffic.

At about 11.05am I was still travelling south, somewhere from the M25 to the M23. I would have to provide a 'guesstimate' of my rough location after tracing my route and being some 20-25 minutes away from Gatwick Airport itself and on the M23 southbound.

Because I was working with a brand new Sat Nav system I could not immediately identify my spot location from the map view (I had a Navman which was in a planned route mode and gave a limited view of where I was). But I think I was on the M23 not too far from the M25 junction .

It was raining to some degree, I had my windscreen wipers operated and car windscreen was clean and without mist with car air-con functional (I drive a Volvo V70). I was in the central lane paying attention to driving hazards and traffic progression (this being skills learnt from the Institute Advanced Motorists standards and police driving standards), basically scanning from horizon to car bonnet and back to horizon taking into account all traffic and it's local environment.

●times I would glance in to the sky to try to get view of flights in bound to Gatwick and an idea of my closeness to destination. It was at this point soon after I saw a flash and bright light in the sky and immediately associated it with a plane or helicopter (where I live in Waltham Abbey gives a regular view of commercial type flights and helicopter flights as a Met police helicopter landing site is near my house about 1 mile. I waited to identify either a jet plane or helicopter. The bright light stopped and (I expected to see the plane or helicopter) allowed a side profile to be viewed as the air-borne vehicle travelled from left to right.

At all times I continued to have casual peripheral vision on the motorway traffic which was continuous and regular. I continued to watch the sky not thinking anything unusual and then this oval shaped object (I now realise it could only match a helicopter in it's side profile was missing it's rear tail), accelerated at a colossal speed, faster than any aircraft I have or been aware of accelerating before and base this on attending airshows as a child and even seeing jet fighters fly over my junior school when a child in Loughton, Essex on the 1970's which included the sound boom.

This unusual oval shaped Ariel vehicle, after accelerating, just vanished out of view. It was quite small in size and appeared to be below cloud cover, but I cannot say categorically. Until it disappeared it was constant and visible and perhaps 1 mile away, but this is hard to say. Overall, this incident lasted for about 5 - 10 seconds. Once it had disappeared, I had limited time to re-assess it's location as my road position changed and meant I had to look to my right and through my driver's door window.

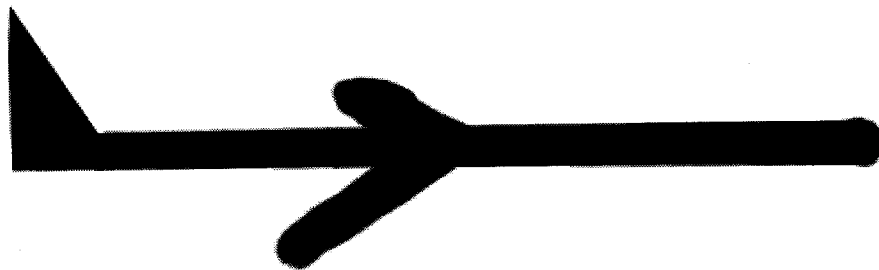

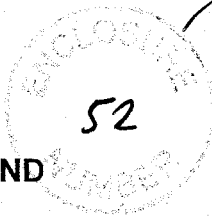

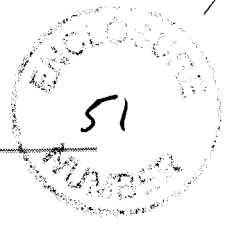

I can't quite believe what I saw tonight, but it made me rush out onto the street camera in hand.

I was very sober when I saw what I am about to describe. Until recently I was a journalist and we used to get similar stories like this from time to time which we would all have a good laugh at (not any more!)

I was sitting on the couch when I saw an orange light in the sky. My initial thoughts were 'that plane is flying low' and I went back to watching TV.

However, five/ten minutes or so later I couldn't believe it when I saw several orange lights - about the same colour and brightness of street lights - about half a dozen in total.

Three of them were closer together than the others and were in a straight, but horizontal line.

I shouted upstairs to my boyfriend, who also witnessed the incident.

I then told him I was getting the camera before running outside - with no shoes on! (the neighbours must think I'm mad).

Unfortunately my camera is not great, but I have attached the pictures anyway in the hope you can enhance them. On the one marked UFO 001 you can see a round shape, which was not visible to the naked eye and only appeared when I blew up the photo. I believe it may show the three lights in a horizontal line I described earlier.

The whole incident could have only happened over a couple of minutes, maybe less.

The lights seemed to fade away, except one which I saw go behind some houses and I followed it a short way down the street on foot before it also disappeared.

The incident happened around 9.20pm today (Saturday 11 April, 2009).

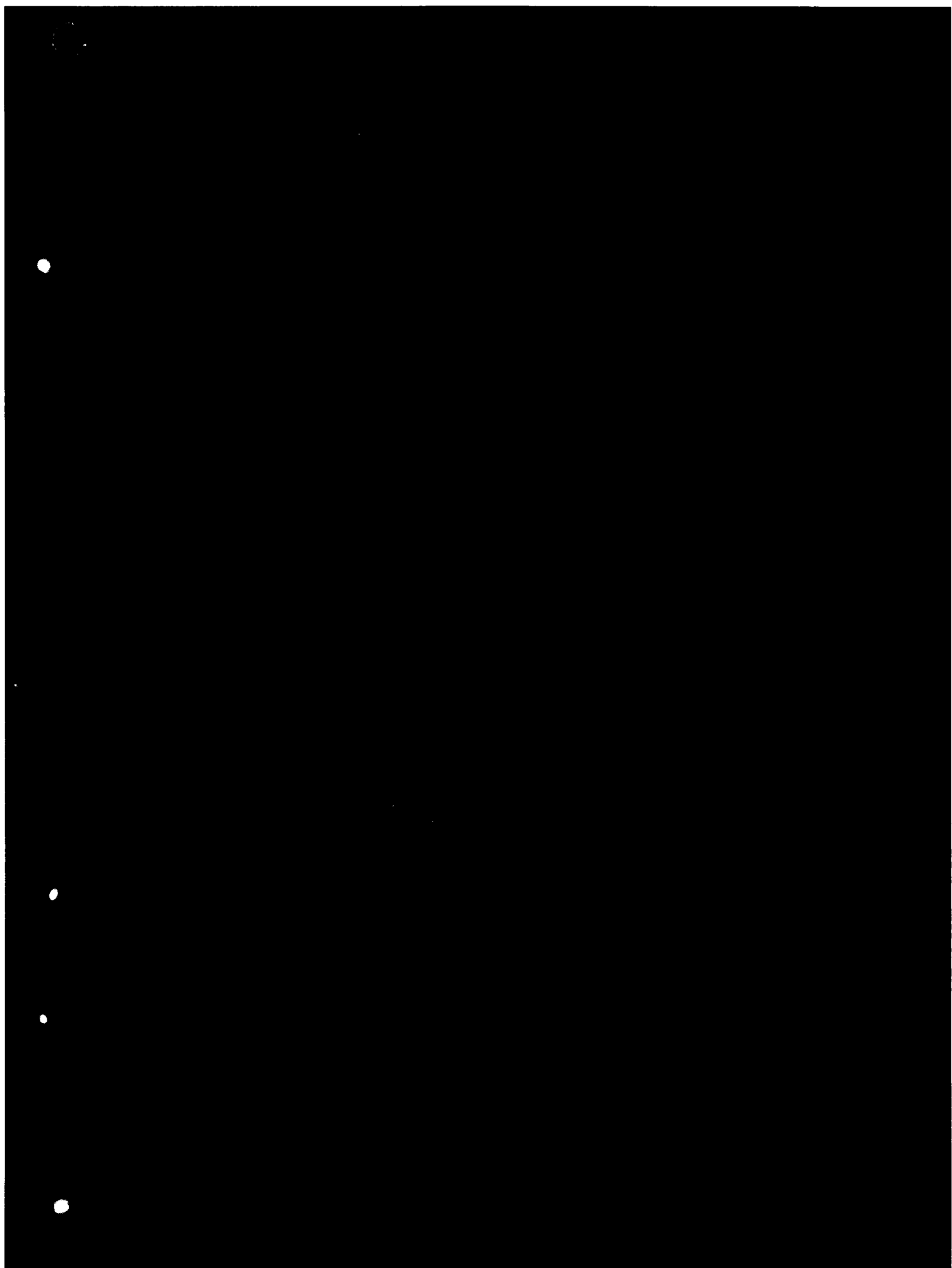

I hope that this is the correct place to make such a report, as I have not done so before. I was recently witness to an airborne object that, for the first time in my life, I could not explain via my own knowledge of conventional aircraft. I have been unable to find anyone to corroborate what I saw, but considering the time and location of my sighting, I can't believe I am the only witness.

I have used Google Earth to obtain accurate headings for the object I saw, and a simple triangulation based upon my angle-of-sight to the object to estimate its altitude.

At 20.25pm on Wed 25th March 2009, whilst walking along the A3100 near Hallam Road (toward Guildford), a very bright spherical object, about the size of a full-moon in sky, passed overhead travelling on a course of approximately 130 degrees (south-east). The object was yellow/orange in colour with just-discernable flashing lights, which I initially took to be the anti-collision beacons and navigation lights of a small aircraft. As it was heading roughly toward Dunsfold Aerodrome, I thought perhaps the pilot had turned on his landing lights, or was maybe flying some kind of aircraft that was highly illuminated for some reason (Top Gear is filmed at Dunsfold, and they get up to all sorts). However, there was no noise from the 'aircraft' whatsoever and it looked strange - the light was very vivid and yet changed as the object moved, as though whatever was within was wrapped in a bright glowing cloud of light. The light also appeared to have quite defined edges, as opposed to aircraft landing lights which would 'diminish' with distance from the aircraft. The object was not a balloon however, as it was far too bright and moving too quickly.

It continued on its heading for roughly 90 seconds, moving toward Hascombe. I kept watching it whilst walking, and saw it suddenly plunge out of the sky. My best estimate is an altitude loss of around 1500 ft in perhaps five seconds. At this point, just above the treeline in the distance and somewhere over Hascombe, the object abruptly arrested its dive and hovered motionless. (It was here that I was finally convinced that the object was not an aircraft, as no aircraft can manoeuvre in this way. A Harrier or helicopter do not have sufficient thrust-to-weight ratios to simply stop dead from such a dive).

Ater hovering for perhaps 30 seconds, the object drifted slowly to the right (west), then climbed before performing a very erratic series of dives, dips and turns, movements completely beyond the capability of any conventional aircraft - almost 'wobbling' along through the sky. It

turned to around 2000ft after about 30 seconds, before slowly fading from view as though its lights were slowly turned off.

I have never before seen something that could not ultimately be explained to my satisfaction with a bit of thought and analysis. My only regret in having seen something like this is that there were no other witnesses - by the time I managed to get a grip on myself and phone my girlfriend on her mobile to look out of her window (her living room faces out over [Section 40](#) toward Hascombe) the object was already fading from view. I tried to stop a passing jogger, but he just kept on moving. However, given the sheer size and brightness of the object, and its passing over Farncombe, Godalming, Hascombe and most likely Dunsfold Aerodrome, I can't believe that I'm the only person who saw it.

Suddenly a swarm of about 100 flashing white lights appeared, high in the sky, moving from the North West very quickly keeping equidistant and of equal speed, and disappearing about 45 degrees above the horizon in the South East. A solitary flashing light appeared behind the swarm and moved faster, apparently trying to catch up. The swarm of lights moved in an arc of about 40 degrees in about ten seconds.

Both myself and my son saw this phenomena. We have no idea what it was. It could be a meteor shower or space debris but the lights appeared to be blinking quite quickly and all at the same frequency. It could be a squadron of planes but there were approximately 100 lights covering a wide path (about 20 degrees) and I have never heard of squadrons of this size flying in peacetime. There were no trails as one would expect with meteors. The lights appeared about the same size and brightness as a bright star.

Do you have any explanation, was there any MoD activity over Nottingham on Sunday night?
