Legal Clash Delays Trial Of Mazerall

Admissability Of Commission Evidence Debated

OTTAWA, May 17—(C. P.)—Legal argument continued this morning as to whether evidence Edward Mazerall, 30, gave before the Royal Commission on espionage should be admitted in his trial in Ontario Supreme Court. With the jury absent, Chief Justice J. C. McCruer directed that the argument not be reported by the press.

A former National Research Council engineer, Mazerall pleaded not guilty Monday to a charge of conspiring to communicate information to Russia. The argument was still proceeding at the noon adjournment and the Chief Justice told the jury members they would not be needed until tomorrow morning.

Crown Contention

The trial hinges on the Crown's contention that Mazerall conspired with several persons to communicate to Russia information he obtained in his Government position. Capt. David Gordon Lunan, 30, one of those with whom he allegedly conspired, declined to testify yesterday when called to the witness box by Crown counsel. He held that his evidence, even though it could not legally be held against him, would hurt him in his own speedy trial tentatively scheduled before a County Court judge May 31.

The Chief Justice declined to hold Lunan in contempt of court and allowed him to leave the stand. His reason was "my view as to the signal importance of preserving a fair and impartial administration of justice." The Chief Justice rejected a defence request for postponement of the Mazerall trial until after that of Lunan.

U.N. Delays Albania Entry

Application Stood Over to August

NEW YORK, May 17—(A.P.)—The United Nations Security Council today adopted unanimously a United States resolution which in effect delays immediate consideration of Albania's request for admission to the United Nations. The Council then adjourned subject to the call of the chairman. The resolution offered May 10 by Edward R. Stettinius, Jr., United States delegate, provides that all applications for United Nations membership submitted not later than July 15 shall be considered by the Council in August. Albania's application is the only one on file. Andrei A. Gromyko, Soviet delegate, called the Stettinius proposal "useless" in view of the new rules on admission adopted today by the Council but went along with the other delegates when the vote was taken. A Grim Picture

French Physicist Reveals New Type of Nuclear War

NEW YORK, May 17—(A.P.)—A new type of nuclear war, using invisible atomic rays so secret that man might know nothing of its start, is forecast by Frederic Joliot, France's foremost physicist.

Dr. Joliot is one of the first two or three scientists to discover that a chain reaction could be produced in uranium. This discovery, rather than that of spitting atoms, led to bombs, atomic power and radioactive ray production. His forecast appears in the current issue of the bulletin of the atomic scientists, Chicago, and is from a talk he made in London.

Security Gone

"In the future," Dr. Joliot says, "a country feeling secure through having in its possession a hundred atomic bombs would one day be warned by its statisticians: 'For five years now they will say, 'the number of abortions (miscarriages) in the central districts has grown to such proportions that there is not one normal birth in six; in the coastal ports fires are destroying the harvest, the drought in the north has deprived the country of a quarter of its electrical energy.'"

"Official headquarters and parliamentarians will pore over these figures and will find one explanation only—for several years war has been waged against their country with immense destruction and a considerable number of victims. Yet no one had known that hostilities had broken out."

The story that Dr. Joliot mentions would come from X-rays of radioactive atomic materials, secretly spread about by enemy agents. He does not mention that there also would be other human injuries, nor explain how a country might fail to recognize the signs. Dr. Joliot does not tell how hostile fires would be started or the weather controlled. But he declares that "one day the pacific applications of this bomb doubtless could be used to transform the surface of large portions of the earth, to make clouds and to bring down rain over huge areas."

Leopardmen Murder 200

Nigerian Secret Sect Goes on Rampage

LONDON, May 17—(Reuters)—Grisly details of more than 200 mutilated corpses, their jugular veins ripped open with leopard claws, form the basis of a secret report on Nigeria's secret societies being sent to London from Lagos, Nigeria, marked for the immediate attention of Colonial Secretary George Hall. The report deals with the mass murder outbreak among the age-old Nigerian Secret Society of Leopardmen. Little is known in London at the moment of the recent flap-up among the blood-sucking leopardmen beyond the fact that more than 100 arrests have been made in connection with the murders. Twelve leopardmen have been convicted of murder and another 38 are awaiting trial.

The secret society was suppressed prior to the Great War but the depletion of the administrative and police staffs in the province gave it an opportunity to start up again. APPENDIX No. I.

THE CYCLES OF CHANGES IN THE EARTH

The following extracts are from a personal manuscript by John H. Tice, Meteorologist, and published privately by the officers and clerics of The Meteorological Research and Publication Company of St. Louis, Missouri, in 1873.

"The half a century scientists have earnestly been laboring to discover such a cycle, but without success, yet every day the necessity for it becomes more evident and the demand for it more earnest and pressing. Professor Lewyer, an English astronomer and renowned as a spectroscopist, expresses himself upon this subject as follows: 'In 3,340,000 days as in Astronomy, the thing is to have a cycle, and if it is not to be found in the Temperature Zones, then go to the Frigid Zones, or to the Torrid Zones to find it. If found, then above all things, and in whatever manner, lay hold of it, study it, record it, and see what it means...'

"Observation on special phenomena, such as sunspots, solar physics generally, magnetic intensity in the Earth, electric tension both of the Earth and of the Atmosphere, auroras, earthquakes, cyclones, rainfalls, and terrestrial temperatures, have been made for half a century, and some for nearly two centuries. Why then, when others have not been more fruitful in valuable results, is owing to the fact that each observer worked in his kindly or friendly, the observations of his chosen phenomena a specialty, without ever dreaming that there was a grand cycle to be discovered by physical phenomena. After dredging up just such a book equal to half the length of what the Esoteric Science is, in the terms of humanity, each observer has contributed to the opinion that his special phenomena had a

periodicity, and repeated itself in a cycle between ten and twenty years....

"After having satisfied myself of the existence of meteorological cycles, about eight years ago, I undertook to investigate their cause with a view of determining their length. As nothing can exist without a cause, synchronous and covariant phenomena regularly repeating themselves in cycles of uniform length, must have a permanent cause that is common to them all, and whatever that may be, and wherever located, it must be ascertainable and susceptible of proof....

"In the preceding part of this work I have demonstrated that winds, rain, snow and hail-forms, cyclones, auroras, earthquakes, in fine, all telluric and atmospheric phenomena are electric; and that whatever may be the cause of the normal condition of the Earth and the atmosphere, the electricity necessary to their production is continually being generated but with varying energy....

"The testimony of the facts presented, incontrovertibly establish these points; that earthquakes have a periodicity in the frequency of their occurrences, and that they show well defined periods of maxima and minima, which alternate regularly as to time with each other. Examinations of the dates of their occurrences show that these maxima and minima are covariants with those of other physical disturbances....

"Earthquakes are caused by disruptive discharges of Electricity through the strata of the Earth. Electric currents, at all times, are circulating through the Earth from East to West. In times of physical perturbations, indicated by sunspots, auroras and great oscillations in the magnetic needle, earth currents, as they are called, often become too intense to be transmitted through the strata of the Earth, and in such cases where the strata are unbroken or of good conductive capacity. These currents where the strata are broken up, or of too feeble conductive capacity, become thinned up, or stopped, until they are strong enough to force a passage, which is effected by what is called a disruptive discharge."

U.S. TAKING A SECOND LOOK AT ITS WORLD ROLE

Americans, pledged to defend 43 allies, find few of them rushing to assist the U.S. in Vietnam—or anywhere else.

Suddenly, the strain of carrying on alone is starting to cause concern, raise questions.

The biggest question: Is it time for the U.S. to pull in its horns, stop trying to police the entire world?

A major reappraisal of the U.S. role in the world is being forced by events.

In Europe, France is throwing roadblocks in the path of the Atlantic Alliance.

Strains are showing in the U.S. military establishment as a result of a small war in Vietnam.

There is a breakup in the alliance underwritten by the U.S. in Southeast Asia. The alliance backed by the U.S. in the Middle East never has gotten off the ground.

In today's world, the American people are committed to defend 43 nations—big and small. This is a commitment by fewer than 200 million Americans to defend 862 million people in much of the non-Communist world.

The one war being fought to fulfill one part of one commitment in a remote area of the world—Vietnam—is taxing the nonnuclear capabilities of U.S. land, sea and air forces.

Danger ahead? Now questions are being raised in Congress, within the military services, among diplomats.

What if another Vietnam should suddenly explode? Suppose Soviet Russia should grow aggressive again in Europe. What if a new Cuba blew up in Latin America? Or if Red China decided to start moving?

Is there the capacity in the armed forces of this country to deal with multiple wars—even if no larger than Vietnam? Would the use, or threatened use, of nuclear weapons then be forced?

And how did the U.S. ever get into a position of responsibility for policing every corner of the globe?

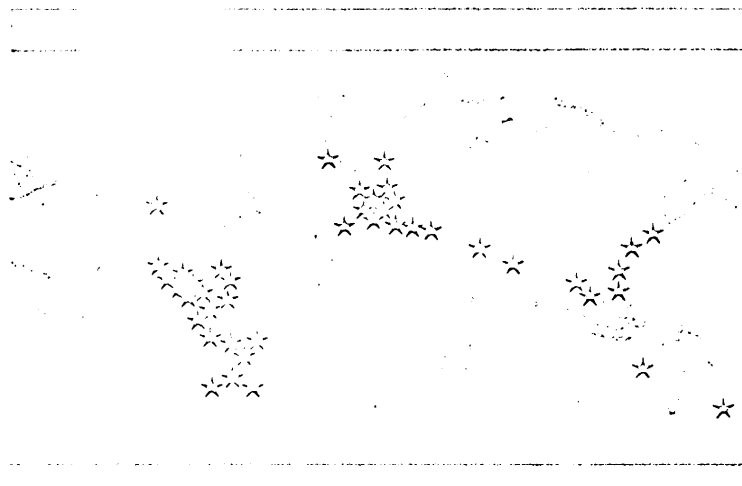
The answer given is that, when these commitments to 43 other nations were made, they rested upon alliances against

Communist expansion, in which other allies were expected to bear a fair part of the burden.

Today those alliances are found to be disintegrating. The allies themselves, with a few exceptions, usually appear uninterested in strengthening ties or adding to their military burdens to defend themselves or their areas. By itself, even

His view: "It should be more than obvious that the United States alone cannot protect the free world against the aggressive and expansionist designs of the Communist nations indefinitely."

Behind the growing concern is the finding of Senate investigators that, while the U.S. was never in better shape to fight an all-out nuclear war, it is not



when spending nearly 60 billion dollars a year for defense, the U.S. is having to struggle to do an effective policing job while tied down in Vietnam.

The strain of Vietnam is now changing the mood of many in this country about carrying the load alone.

On May 4, Senator Stuart Symington (Dem.), of Missouri, cautioned that the U.S. is "overcommitted" in its military pledges around the world and said steps must be taken to deal with the situation. Senator Symington, as a member of the Foreign Relations and Armed Services committees, sees many secret reports. He said that either overseas commitments should be reduced or "major changes" made in U.S. military readiness.

Chairman John Stennis of the Senate Preparedness Investigating Subcommittee is another calling for a new look.

in sound military shape otherwise. Where nuclear strategic power is concerned, the U.S. has quietly been expanding and modernizing a vast force of Air Force Minuteman and Navy Polaris missiles. These are weapons of mass destruction and, it is pointed out, of no value in a situation such as Vietnam.

In almost every respect other than strategic power, the Air Force and Navy are found to be stretched thin.

Airlift and seairlift for emergencies outside Vietnam would be hard to mount on short notice. Tactical air power of both services is being worked overtime to keep up with needs in Vietnam. There is some concern expressed about the readiness of both the Atlantic Fleet and the Seventh Army in Europe if real trouble should break out there.



The Honourable Leo Cadieux, Minister of National Defence, has asked me to advise you with reference to your letter of April 8, 1950, that reports of unidentified flying objects are by no means taken lightly by the Canadian Government.

The Government is concerned about this and other similar phenomena, both from the point of view of their possible scientific interest and with respect to their significance insofar as national security is concerned. So far none of the sightings reported have turned out to constitute a threat to national security but a number have been of interest from a scientific point of view, particularly to the National Research Council Meteor Centre.

A brief history of "unidentified flying objects" is attached which may be of interest to you.

His letter deals with a subject that is of great importance to all men, women and children living on this Planet. Your letter of 9 April, 1966, addressed to the Department of Transport, which reported your observations of "flying objects", has been passed to me for study.

The descriptions you give of your sightings suggest that you have been seeing the ECHO satellites, which are very large balloons. These reflect sunlight and can usually be seen for about ten minutes at a time as they move across the sky. If one knows exactly where to look for them, it is sometimes possible to see one of these satellites three times in a single evening—once low in the east shortly after dark, again about two hours later overhead, and a third time to the west after another two hours. As they do not appear in the same place each night, but gradually move westward and are seen a little later each night, they can be seen in any one place for a few months at a time and will then not be visible for several months.

I have had the times of your sightings, together with the direction of travel, checked by personnel at the Dominion Observatory and the National Research Council, who observe different satellites. They are certain that most of your observations were made on the ECHO II satellite, which would have travelled from W-NW to E-SE in the evening and from a southerly to a northerly direction in the morning during December and January, and then after several months when you could not see it, would have appeared again moving in the reverse direction by early April, as its orbit had rotated halfway around the earth. ECHO I does not come as far north as ECHO II and therefore would have appeared to you to move from east to west, or from west to east, as reported by you on several occasions.

On 12 January, 1966, it would appear that you saw them both together—one moving W-E and the other W-SW. I once saw two satellites cross in a similar fashion about six years ago, and you are the only other person I have ever heard of doing the same thing. In my case, one was an American satellite and the other was a Russian one.

In your report you noted in two places that the moving object appeared to pause. I think that this must have been either an optical illusion or in looking away and back again, you briefly confused the satellite with a bright star or perhaps the satellite passed in front of a bright star and you missed it on the other side for a short time.

I found your report interesting and I want to compliment you on the obvious care you took with your records. Many reports which reach this department are too vague and inaccurate to be of any value. So that you will have a better idea of what you have been observing, I am enclosing brief descriptions of the two TCRD satellites. I might add that there are other satellites which are visible to the naked eye, but they are not nearly as bright as these two and are unlikely to be observed unless one knows exactly where and when to look.

I hope the above information will be of some interest and value to you.

At approximately 11:00 P.M. a telephone call was received from (2) stating that this same date, whilst he was driving his vehicle in the Clarenceville, Que., area, he witnessed what he believed to be a meteorite in its fall. Details as obtained from (2) are being summarized according with par. 4, CO-Air, Operational Manual.

- 2. (a) DATE AND TIME OF SIGHTING: 25 APR 66, 8:15 P.M.
- (b) CONDITION OF SKY: Clear, moon shining.
- (c) LOCATION OF OBSERVER: 1½ mile north of Clarenceville, Que., driving south.
- (d) OCCURENCE OF BURSTS: None reported.
- (e) LUMINOSITY: Very bright, compared to a manganese light.
- (f) COLOUR: Very bright greenish blue, trail of red sparks.
- (g) FORM: Round when afire, size of a \$0.50 piece, (Taken to be approximately the size of the moon.)
- (h) DURATION: Fireball; about 3 seconds;
Trail; about 1½ minute.
- (i) SOUNDS: No sound heard.
- (j) POSITION IN SKY: Estimated travelling at 7000 feet in the air, northerly direction. Observer was travelling south, was 1½ mile north of Clarenceville, Que., when he made the observation and the fireball was observed to his right or to the west of his position.
- (k) OTHER OBSERVATIONS: (2) was accompanied by (2) of Clarenceville, Que., who also observed the fireball. (2) furthered that two (2) chunks remained after desintegration and each were about the size of a car. These chunks appeared to him to have fallen between Clarenceville and Noyan, Que., a few miles north of H'way #52.

Whilst attending to other police matters in the Clarenceville, Que., area, two other witnesses of the fireball in question residing on the east shore of the Richelieu River being to the west of (2) position, were interviewed. They both narrated their observation which is very similar in detail to (2) except that they did not observe any remaining chunks. They observed the fireball to the west of the Richelieu River and same was travelling towards Montreal, Que. From these observations we believe that (2) underestimated the fireball's height and position in relation to us.

1 With reference to S2000-4(DG1/1P4) dated Aug 65, the undersigned proceeded to Foster Quebec at 0615 hrs on the 3 Sep 65, and received from (2) in object which fell from the sky and landed in the (2) driveway.

2 The following informations were also received from (2) and later confirmed by her son: (2)

- (i) This incident took place on the 3 Aug 65 at approximately 1215 hrs in front of the (2) residence at Foster, que. See attached road map for approximate location.
- (ii) (2) said that he heard a whistling sound coming from the falling object instants before it hit the top of a tall tree located in front of his home. The boy who was riding his bicycle home at the time heard the object crashing through the branches to finally land a few feet in front of him in the driveway.
- (iii) He did not notice any large birds or aircraft flying in the area at the time.
- (iv) High wind prevailed at the time and he recalled that it required extra efforts to bicycle home. Also a great storm struck the area around mid-afternoon on that day.
- (v) The investigator also visited a (2) residing at Boulton (see map). This lady, a friend of the (2) when she heard of the falling object had mentioned to (2) hearing a strange noise at approximately the same time and date. When asked by the undersigned, she replied that on the 3 Aug 65 while the family was taking the noon meal, they all heard a noise resembling that of a car being driven wildly or a low flying aircraft. She had nothing else to add.
- (vi) Returning to base the undersigned showed the recovered object to CTSO and on his advice took it to Aircraft Industries Limited, St Jean, que, a civilian organization servicing a/c belonging to this unit. It was learned that this item definitely did not come from an RCAF a/c and that it probably came from either a light a/c or an helicopter.

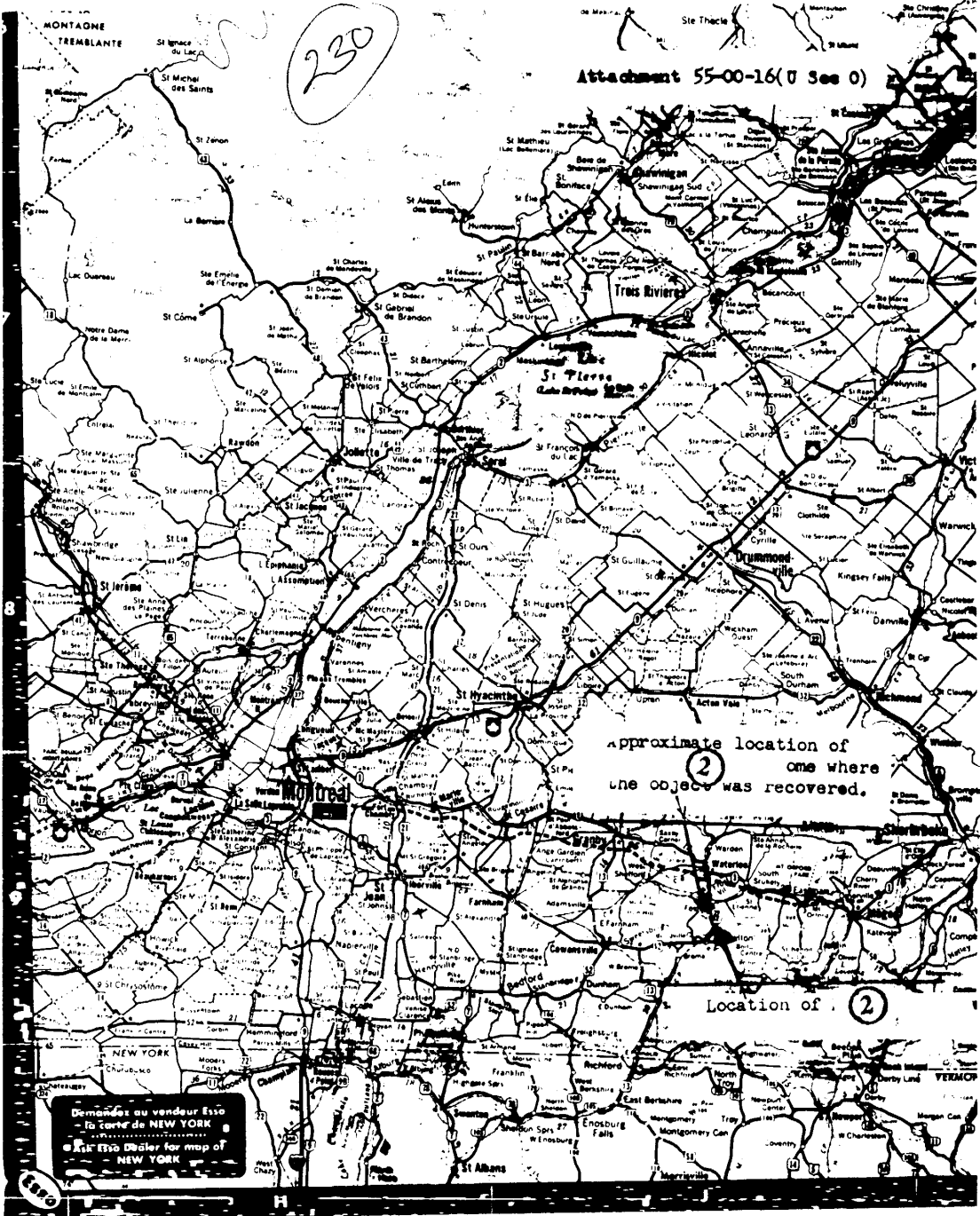
